**Terms and Conditions**

The Fédération Internationale de Teqball (FITEQ) ("FITEQ", "We", "Our", "Us") is pleased to provide you with its website(s) (the "FITEQ Websites"), applications (the "FITEQ Apps") and other digital services, content and software ("Services") (together, hereinafter referred to as "FITEQ Digital Platforms"). The following Terms and Conditions and any documents referred to herein ("Terms") apply to all FITEQ Digital Platforms, unless stated differently in relation to a specific FITEQ Digital Platform.

#### 1. ACCEPTANCE OF TERMS

- 1.1 By accessing, downloading, installing, or using the FITEQ Digital Platforms, whether or not one become a *registered* user, any such users and visitors ("User", "You", "Yourself", "Your"), You agree to be bound by these Terms, which You acknowledge to have read and understood.
- 1.2 We reserve the right, at Our sole discretion, to change, modify or otherwise alter these Terms at any time. You must review these Terms at <a href="https://www.fiteq.org">www.fiteq.org</a> on a regular basis to keep Yourself informed of any changes.
- 1.3 By using the FITEQ Digital Platforms, You agree that the posting of new or revised Terms on or within the FITEQ Digital Platforms shall constitute adequate and constructive notice to You of any and all revisions and changes. Continued use of the FITEQ Digital Platforms after any such changes or after explicitly accepting the new Terms upon logging into the FITEQ Digital Platforms shall constitute Your acceptance of such changes.
- 1.4 The use of particular Services may be subject to specific terms and conditions related to the Service concerned. By using such Services, You agree to be bound by the terms then in force. Where there is any inconsistency between the Terms and any specific terms and conditions, those specific terms and conditions shall prevail in respect of the Service concerned.

# 2. REGISTRATION

2.1 Users may sign up for an account and become an individual affiliate of FITEQ as an athlete, coach, referee and other technical professionals as defined by FITEQ's Statutes ("Individual Affiliate"). The registration process is governed by the Statutes and these Terms. In addition, Individual Affiliates may also conclude separate agreements with FITEQ. Where there is any inconsistency between the Terms, and those separate agreements, the latter shall prevail.

# 2.2. Eligibility criteria

To become an Individual Affiliate, You must:

- 1) Meet the eligibility criteria set out below in accordance with Section 2.3.1 and 2.3.2. of the Statutes applicable to the respective category of Individual Affiliates You wish to become.
  - a. For athletes/players, the relevant requirements are as follows:
    - (a) You must meet the requirements as described in the FITEQ Policy for Age Categories and Minimum Age Requirements;
    - (b) You must not be under any sanctions relating to tegball and/or the WADA Code;
    - (c) You have not been prosecuted by any governmental authority for infractions relating to sports, including violations of integrity and anti-doping;
    - (d) You must submit a copy of the personal data page of an official form of photo identification in the country of Your nationality;
    - (e) You must pay, and provide proof of payment of, the applicable annual Membership fee (if any);
    - (f) You must register at www.fiteq.org;
    - (g) Be sufficiently fit to participate in the competitions.
  - b. For coaches, referees and technical officials, the relevant requirements are as follows:
    - (a) You must not be under any sanctions relating to tegball and/or the WADA Code;
    - (b) You have not been prosecuted by any governmental authority for infractions relating to sports, including violations of integrity and anti-doping;
    - (c) You must submit copy of the personal data page of an official form of photo identification in the country of their nationality;
    - (d) You must pay and provide proof for the relevant Membership fee, if any;
    - (e) You must register at www.fiteq.org.
- 2) Meet the legal age requirement set out herein in case of US nationals at least 21 years of age, in case of Non-US nationals at least 18 years of age, hereinafter "Legal Age". In case you are below the Legal Age, You acknowledge that Your parent(s) or legal guardian(s) must acknowledge or approve Your registration. Learn more about the age of majority and parents' and legal guardians' obligations under Section 3 hereof.
- 3) Possess full legal competence, or in case of limited or no legal capacity, You acknowledge that Your parent(s) or legal guardian(s) must acknowledge or approve Your registration. Learn more about legal competence and parents' and legal guardians' obligations under Section 3 hereof.
- 4) Hold a valid email address.
- 5) Act in Your personal capacity rather than representing another natural person, or commercial or non-profit organization.

## 2.3. Warranties

By setting up your account and submitting your registration request to become an Individual Affiliate, You acknowledge, certify and warrant that:

- (i) You meet the requirements set forth in FITEQ's Statutes, regulations, policies, bylaws ("Rules") and these Terms (with particular reference to (a)-(b) of Article 2.2. 1) a. and 1) b. and the Legal Age and legal capacity-related requirements);
- You accept FITEQ as the global governing authority of Teqball and para Teqball, authorized to take disciplinary actions against You, and apply corrective actions and penalties as per FITEQ's internal procedures;
- (iii) The information You provide to Us as part of the registration process is accurate, true, current, complete and not misleading;
- (iv) You maintain and, in case of changes, promptly update the data You provided during the registration process to keep it true, accurate, current and complete;
- (v) You duly cooperate with FITEQ and the competent national sports associations recognized by FITEQ as the local governing body of the sport of Teqball and para Teqball in line with FITEQ's Statutes ("National Federation") and the competent local sports associations / clubs ("Club") under the jurisdiction of the relevant National Federation in connection with Your registration.
- (vi) You register and maintain only one FITEQ account. FITEQ does not accept multiple accounts registered for the same person.

Further, You acknowledge that If You provide, or FITEQ has reasonable grounds to suspect that You have provided, any information that is untrue, inaccurate, not current or incomplete, or FITEQ otherwise reasonably considers that You have failed to comply with any provisions of the Statutes or these Terms, FITEQ has the right to suspend or terminate Your membership and account and refuse You any and/or all current or future use of the FITEQ Digital Platforms (or any portion thereof).

## 2.4. Registration process

When setting up Your account and submitting Your registration request, You may be asked to pay a certain amount of an affiliation fee ("Membership fee") to FITEQ. The Membership fee may be paid upfront as a lump sum fee (annual fee) or in monthly installments (monthly fee) in line with the Athlete Payment Implementation Policy applicable to all Individual Affiliates. Please find this document here.

Upon receiving Your registration request, FITEQ takes all measures necessary to assesses its content, including carrying out formal and substantive review. Within the frame thereof, FITEQ may request information for, among others, verifying Your identity, the approval/authorization of Your parent(s) / legal guardian(s) as per Section 3 hereof including carrying out ID verification of Your parent(s) / legal guardian(s) and assessing Your compliance with the applicable medical fitness rules.

Please note that, You will automatically be assigned to the National Federation having jurisdiction over the country You are a citizen of (if such National Federation exists). When submitting Your registration request, You may freely choose from Clubs duly recognized by FITEQ and operating in the relevant territory. Such automatic assignment to the competent National Federation and the Club of Your choice

are deemed to establish separate legal relationships (separate membership) between the relevant National Federation, Club and Yourself. This is, however, without prejudice to any additional membership procedures or requirements in place at the National Federation, the Club, and in any and all membership agreements You may conclude with those entities. FITEQ cooperates with the competent National Federation and Club when assessing Your registration request at FITEQ.

FITEQ shall duly notify You of the status of Your registration, and also reserves the right to reject such requests in case of Your non-compliance with the Statutes, these Terms and the Rules.

### 2.5. Technical rules related to Your FITEQ account

You will receive a password and a personal account upon completing a registration process (as described in this Section 2). You are fully responsible for maintaining the confidentiality of the password and account, and for all activities that occur under Your password and account.

You hereby agree to: (i) immediately notify FITEQ of any unauthorized use of Your password or account and any other related breach of security; and (ii) ensure that You sign out of Your account at the end of each session. FITEQ cannot and will not be liable for any loss or damage arising from Your failure to comply with this section.

FITEQ may, in its sole discretion, including if You breach these Terms, with or without prior notice and at any time: (i) terminate Your access (whether restricted or not) to the FITEQ Digital Platforms, in whole or in part; and/or (ii) deactivate or delete Your account and all related information and files as well as Your User Submissions (as defined below). Please also note that, in such an event, Your access to Content (as defined below) might also be terminated.

# 2.6. Your rights and obligations after a valid registration

As an Individual Affiliate, You shall be bound by the final decisions, Rules and guidelines of FITEQ and shall comply with the values, provisions and principles of FITEQ's Statues and Rules. You shall regularly visit www.fiteq.org and learn about all published Rules and other communication. You expressly acknowledge and accept that Rules and communications are deemed as delivered upon their publishing date on the FITEQ website.

Further, the details of Your relationship with FITEQ shall be subject to separate agreements. In case of Athletes, You or your parent(s) / legal guardian(s) will be asked to sign a FITEQ Player Agreement detailing Your rights and obligations vis-á-vis FITEQ. In case of Coaches and Referees, additional registration and education requirements apply (If you want to learn more about these requirements, please visit this site.) and their further rights and obligations are subject to separate service agreements concluded for one or more FITEQ-sanctioned event.

## 2.7. Termination of membership

You may terminate Your membership at FITEQ with 5 business-days' notice by sending a reasoned request to EMAIL.

Otherwise, the suspension and termination of Your membership shall be subject to the Statutes and Rules of FITEQ.

# 3. MINORS, PERSONS OF LIMITED LEGAL COMPETENCE AND LEGALLY INCOMPETENT PERSONS

- 3.1. FITEQ cares about the safety and privacy of all its Users, particularly those not yet of legal age, persons of limited legal competence and legally incompetent persons, in accordance with the laws of their respective country of nationality. As such, FITEQ set the following thresholds previously defined as Legal Age as follows: all persons wishing to register on FITEQ Digital Platforms (with particular reference to applying for membership) shall be regarded a minor if i) in case of US nationals they are below the age of 21, ii) in case of all other countries' nationals, they are below 18 years of age. For the purposes of this section, legal competence shall refer to the natural person's ability to conclude contracts and make other, valid and legally binding statements. One's legal competence can be partially or fully limited. As such, in accordance with the laws of their respective country of nationality, the validity and binding nature of any such acts of Users may be subject to the approval, acknowledgement or authorization of their parents or legal guardian(s).
- 3.2. For this reason, parents/legal guardians who wish to allow their children or the person placed under their guardianship or conservatorship access to the FITEQ Digital Platforms must carefully review and accept these Terms, as well as supervise their access to the FITEQ Digital Platforms. By allowing Your child / the person placed under Your guardianship / conservatorship access to the FITEQ Digital Platforms, You agree to be bound by these Terms, and acknowledge that he or she will be able to access all of the FITEQ Digital Platforms, which may now or in the future include public and private communication tools, as well as other features that may not be appropriate for their use. Please remember that the FITEQ Digital Platforms are designed to appeal to a broad audience. Accordingly, as a parent/legal guardian, it is Your responsibility to determine whether any of the FITEQ Digital Platforms and/or Content (as defined below) are appropriate for Your child or the person placed under Your guardianship / conservatorship. You remain responsible and liable for all acts of these Users.
- 3.3. The registration of Your child / the person placed under Your guardianship / conservatorship are subject to the rules described under Section 2 hereof. You will be asked to take further measures, including expressly providing Your consent to one or more relevant statements made by Your child / the person placed under Your guardianship / conservatorship.
- 3.4. In case a minor reaches the Legal Age, they shall renew their membership at FITEQ in accordance with the applicable FITEQ Rules in force. In case of any change to the legal capacity as described above, FITEQ shall be immediately informed of such change using the following email address: EMAIL. In that event, FITEQ may request relevant supporting documents substantiating the change.

#### 4. INTELLECTUAL PROPERTY AND CONTENT

- (i) Intellectual Property of FITEQ
- 4.1 Subject to Sections 4.4 (User Submissions) and 4.9 (Third Party Content), FITEQ is the owner and/or beneficial holder of the copyright and all intellectual property rights in and to the FITEQ Digital Platforms, and to all information, data, text, software, music, sound, photographs, graphics, videos, messages, feeds offered through and displayed/presented on the FITEQ Digital Platforms ("FITEQ feeds"), the application programming interface ("FITEQ API"), and any other material on the FITEQ Digital Platforms (together the "Content").

- 4.2 The FITEQ Digital Platforms include Content: (i) provided by FITEQ ("FITEQ Content"); (ii) that is uploaded, posted, submitted or otherwise transmitted by Users of the FITEQ Digital Platforms ("User Submissions"); and (iii) that is uploaded, posted, submitted or otherwise transmitted by third parties, including in the form of links or feeds from or to other websites or resources ("Third-Party Content").
- 4.3 Content may not be used, reproduced, distributed, transmitted, broadcast, displayed, sold, licensed or otherwise exploited for any other purposes than for accessing and using it on the FITEQ Digital Platforms save as permitted pursuant to Section 5.2 below. For that sole and exclusive purpose, FITEQ grants You a limited, revocable, non-exclusive, royalty-free licene to access the FITEQ Digital Platforms and use the Content strictly for the purpose of using the FITEQ Digital Platforms privately for non-commercial purposes, in accordance with these Terms. FITEQ and/or its licensors reserve all rights on the FITEQ Digital Platforms and the Content. Further, You shall not contest, dispute, challenge, oppose or seek to cancel FITEQ's and the TEQBALL Group's right, title, or interest in or to the Content. You shall not apply for registration of the Content or any intellectual property substantially similar, in whole or in part, thereto.

## (ii) User Submissions

- 4.4 You retain all rights in any User Submission that You provide on the FITEQ Digital Platforms. You shall be solely responsible for Your own User Submissions and the consequences of uploading them.
- 4.5 The FITEQ Digital Platforms may provide, in some cases, unfiltered access to User Submissions. You hereby acknowledge and agree that FITEQ only acts as a platform for such User Submissions and that We are not liable for such content posted on the FITEQ Digital Platforms, whether arising under intellectual property laws, libel, privacy, obscenity, or otherwise. FITEQ cannot, nor does it undertake any obligation, to control User Submissions. By their very nature, User Submissions on the FITEQ Digital Platforms are changed frequently, may be inaccurate and in some cases may be mislabeled or deceptively mislabelled. FITEQ does not make any representation or warranty, express or implied, as to User Submissions.
- 4.6 You represent and warrant that Your User Submissions: (i) shall not infringe any copyright, patent, trademark, trade secret, or other proprietary rights or right of publicity or privacy, including for any use by FITEQ pursuant to the license granted under Section 4.7; (ii) shall not violate any law or regulation, including any agreement You may have with FITEQ (e.g. Player Agreements, etc.); (iii) shall not be defamatory or trade libelous; (iv) shall not be obscene or contain pornography; (v) shall not include incomplete, false or inaccurate information about Yourself or any information about any other individual; and (vi) shall not contain any viruses, Trojan horses, worms, time bombs, cancelbots or other computer programs that are intended to damage, detrimentally interfere with, surreptitiously intercept, exploit or expropriate any system, data or personal information. You, in particular, represent and warrant that You have the written consent, release, and/or permission of each and every identifiable individual in any User Submission to use their name or likeness.
- 4.7 You grant FITEQ an irrevocable, worldwide, non-exclusive, royalty-free, perpetual, sub-licensable and transferable license to use, reproduce, distribute, prepare derivative works of, display and perform User Submissions (not including Your real full name, contact details, addresses and financial details) in

connection with the FITEQ Digital Platforms or FITEQ's (its successor's and the TEQBALL Group<sup>1</sup>) business for any purpose, including promoting and redistributing part or all of the User Submissions (and derivative works thereof) in any and/or all media formats and through any and/or all media channels.

4.8 You hereby acknowledge and agree that FITEQ has no obligation to post any User Submission from You or anyone else. In addition, FITEQ may, at its sole discretion, edit, remove or delete any User Submission that You post or submit, as well as terminate Your access to the FITEQ Digital Platforms without notice if, in its opinion, such User Submission infringes another individual's intellectual property rights or otherwise does not comply with any provision of these Terms. In particular, FITEQ reserves the right to determine the final design, layout and functionality of the FITEQ Digital Platforms, which may involve the review, formatting and editing of User Submissions.

# (iii) Third-Party Content

4.9 You acknowledge that FITEQ Digital Platforms may contain links to third-party websites and to their contents ("Third-Party Content"). FITEQ has no control over Third Party Content, including APIs, links or feeds from or to other websites or resources. You hereby acknowledge and agree that FITEQ is not responsible for the availability of external sites or resources, does not endorse, and is not responsible or liable for, any Third-Party Content available on such sites or resources. When You access other websites from links on the FITEQ Digital Platforms, those websites may operate under different legal terms and privacy policies. We encourage You to read the legal terms and privacy policies for each such website. These other terms and policies will apply to You when You use these third-party website or services. We have no control over such third-party websites. You further acknowledge and agree that FITEQ shall not be responsible or liable, directly or indirectly, for any damage or loss caused or alleged to have been caused by or in connection with the use of, or reliance upon, any Third-Party Content, goods, services or any other material available on or through any APIs, links or feeds from or to other websites or resources.

#### 5. LINKING AND USE OF FITEQ DIGITAL PLATFORMS AND FITEQ CONTENT
